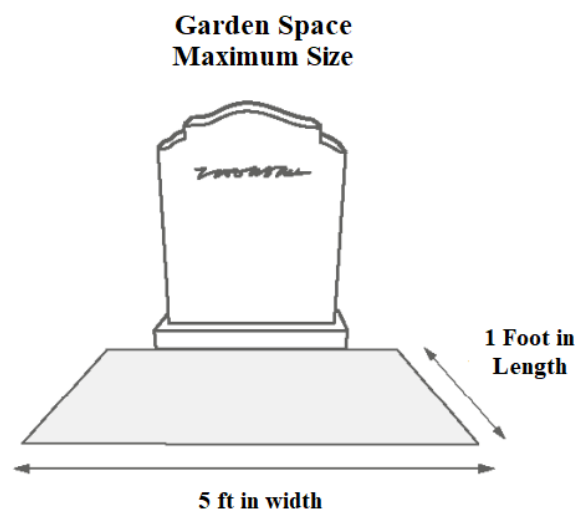

Lawn Graves will be seeded over following settlement of the grave with can take approximately one year. Grass seeding will be carried out between October and April as weather allows. The remaining grassed area must be kept clear at all times.

Garden Spaces with a maximum size of 5ft wide by 1 ft in length, in front of the landing will be available for individual planting and tributes. The grave owner is responsible for maintaining this area.

1. Any items placed on the grave are at the owner's risk. The Council cannot be held liable for any damage or breakages.
2. No memorial may be erected upon the grave surface which shall be completely turfed/seeded flat to the surrounding ground level.
3. The Exclusive Right of Burial is for a maximum period of **Fifty Years** (Minimum 10 years with no memorial rights and minimum of 25 years with memorial rights) with the option of renewal during or at the end of the term.
4. A fee is payable according to the scale of charges in force at the time of application, this rate is determined by the residency of the proposed registered owner. The address details will be checked with the Electoral Register to ensure correct charges are charged.

I have received a copy of the Cemetery rules and regulations and understand that by paying for the Grant of Exclusive Right of Burial I am confirming I have read and understood the rules and regulations and I am legally bound to abide by them. I hereby indemnify Stamford Town Council and all its officers and servants from any liability whatsoever in this matter or arising thereof. I hereby declare that as the registered owner to be legally bound by the Rules and Regulations and any further amendments as result of legislative changes.
