

Stamford Cemetery

Extension to Deed of Grant

The Grant of Exclusive Rights of Burial is issued for an initial period of 50 years and may be renewed up to a total maximum of 50 years. The Deed will state when the Rights were issued and how long for.

A registered owner can apply to the Stamford Town Hall Bereavement Services at any time to extend the Deed in blocks of 10 years at one fifth of the current full 50-year term cost. To extend the Rights to a grave, the registered owner can contact the Stamford Town Hall Bereavement Services to confirm the cost and return this form, with the original deed and appropriate fee. You may pay by Cash, Cheque (made payable to Stamford Town Council), BACS, or card at the Town Hall. The deed will be endorsed and returned to you.

Once the Rights have expired, the ownership reverts to the Burial Authority (Stamford Town Council). If the Rights have expired, you can still apply to re-purchase the plot. Please contact the Town Hall for a re-purchase application form.
