Re-purchase of Deed of Grant

The Grant of Exclusive Rights of Burial is issued for an initial period of 50 years and may be re-purchased up to a total maximum of 50 years. The existing Deed will state when the Rights were issued and how long for. Once the Rights have expired, the ownership reverts to the Burial Authority (Stamford Town Council).

To apply to re-purchase the Rights to a grave, please contact the Stamford Town Hall Bereavement Services to confirm the cost and return this form, with the original deed and appropriate fee, Rights can be re-purchased in blocks of 10 years at one fifth of the current full 50-year term cost. We will send you a new Deed showing how many years have been re-purchased. This can also be extended in the future. You may pay by Cash, Cheque (made payable to Stamford Town Council), BACS, or card at the Town Hall.
